

Veteran Onboarding Information and Agreement

Preliminary Stage 1: Application process

You must complete the online application and have provided all the information requested by us. All the information is required and cannot be processed unless complete. **PLEASE READ THIS DOCUMENT CAREFULLY.**

Phase 1: Warrior Academy (instruction)

Warrior Academy consists of 40 instructional modules, with references and brief assignments necessary to help develop the concept into a business plan. Warrior Academy is based on the format of a military Operations Order and is intended to allow the veteran to "translate" his already-existing military skills into equivalent skills needed to stand-up and execute a potentially viable business.

Phase 2: Coaching

Upon acceptance to Warrior Academy, veterans are provided with access to bi-monthly coaching sessions. Sessions are composed of a keynote speaker with an assigned topic followed by multiple breakout rooms covering various subtopics. These sessions also provide an opportunity to interact with Warrior Rising staff directly for questions, concerns and comments.

Phase 3: Business Showers

Once a quarter, grant opportunities are provided for veterans that have completed Warrior Academy called Business Showers. These events are a combination of a Shark Tank-style pitch contest and bridal shower. If selected for a Business Shower, Veterans are given a laptop computer, business suit, website development, professional headshots, and a promotional video, as well as the opportunity to pitch off in front of judges, investors and peers for a chance to earn a grant of up to \$20,000 and access to one-on-one mentoring.

At this stage, you must have submitted:

- DD-214
- Headshot (photograph),
- CV/bio/resume,
- business description/history/background,
- Logo (if any), and
- A video of your elevator pitch describing your business and why someone should support it (no more than 3-4 minutes).

Phase 4: Mentor Assignment

Mentors with significant business experience (in various stages of business) will be assigned to the veterans once they have reached this stage (and have completed the previous stages) to assist them with:

- developing a go-to market strategy,
- establishing and collecting analytics necessary for operating their business/attracting investment
- obtaining outside advisors (legal and accounting)



determining and developing an optimal financing strategy

Stage 5: Funding Opportunities

Warrior Rising assists with funding in several ways:

- Direct Introduction to Potential investors, through our Business Shower events (investment is not guaranteed, however)
- Loans (revenue-based financing)
- Grants through our Business Shower and other events

Stage 6: Warrior Community

Warrior Rising wants you to always feel like you are part of a community of veteran entrepreneurs. Even after you have completed Warrior Academy or achieved the desired results through our Mentorship Program, our goal is to provide a venue for participating in events in your local areas. We need you to, in turn, be supportive of Warrior Rising's mission. By participating in our programs you are expected to:

- Become a mentor to future veterans who will be facing what you faced in starting your business;
 Participate as a speaker or give presentations sponsored by WR to groups of veterans on topics that are relevant to your experience;
- Positively and productively participate, promote, and assist, to the benefit of WR, and upon the reasonable request of WR, in WR fundraising activities and all outreach efforts (public relations, marketing) and help support WR financially when your business is sustainable.
